



Positively Public Campaign Update

CUPE Local 500 is campaigning to protect public services!

Over the past four years, Local 500 members have faced a growing attack on the way public services are delivered to the citizens of Winnipeg. Since 2005, garbage collection has been privatized, the City's Glacial Sand and Gravel Operations were sold and Assiniboine Park has been handed over to a private board to run.

In 2007, the Mayor released a document known as the Economic Opportunity Commission (EOC) Report which targeted a number of specific public services for elimination, downsizing and contracting out or privatization. In response to these threats, Local 500 launched a multi-faceted four-year campaign aimed at stopping the contracting out, shutting down and privatization of Winnipeg's public services.

The following highlights some of our strategies, action plans and results in our fight-back efforts to protect public services.

Service Targeted

311 Contact Centre

Three consolidated service delivery options proposed:

- internally operated service;
- outsourced to the private sector;
- hybrid model (one which outsources infrastructure and utilizes city staff).

*City favoured outsourcing

Contacting out of golf course operations and maintenance

- City contracts out aeration services
- No formal notice to Union to contract out talks going at City "behind the scenes"

Contracting out of custodial services

 City of Winnipeg business plan - June 30/08 contracting out of 38 custodial services positions in Building Services

<u>City attempts budget reductions and operational changes to Park Police</u> Services

 City attempts to reduce 14 Park Police Officers to 7 and proposes operational changes to park policing

<u>City proposes and subsequently</u> <u>approves Municipal Corporate Utility</u> <u>Model</u>

- November 2008, City Council votes to explore Municipal Corporate Utility (MCU)
- Also approved to use P3 method to design, construct, finance and operate water and waste control centres
- In July 2009, Winnipeg City Council voted in favour of creating a Municipal Corporate Utility to operate city water and wastewater services. They will use a 'strategic partner' or business method (publicprivate partnership) to "design, construct, finance and operate" water and waste control centres

Union Response/Results

Union Response

- Nine month campaign
- 311 Committee formed
- Committee develops recommendations for internally operated 311 Centre
- Presentations at EPC/City Council

Result: City Council approves internally operated 311 Contact Centre

<u>Union Response</u>

- Policy Grievance filed re: contracting out of aeration services
- Distribution of leaflets at municipal golf courses

Result: Policy grievance upheld - no further attempts made to contract out

<u>Union Response</u>

- Letter to CAO
- Union committee formed
- Joint discussions between union and city

Result: Custodial services remain inhouse

Union Response

- Meetings with City and Park Police Staff
- Leaflets distributed by Park Police Officers
- Presentations at Standing Committee / EPC /City Council

Result: Motion to reduce/change Park policing defeated at City Council - services/jobs remain with Local 500 members

<u>Union Response</u>

- Presentation to City Council Nov. 18/08 and July/09 to EPC (29 delegations) & City Council (17 delegations)
- Union representation on City advisory committee/three subcommittees
- Local 500 Water and Waste Unit member support /involvement
- Coalition of community, student, church and union groups formed
- Participate/attend public water events (world water day; water forums, etc.)
- Use of promotional materials water bottles
- Highlight water issue as part of overall ad campaign
- · Meetings with the Province held

Overall Campaign Actions/Activities

Member and Public Awareness

- Create awareness/involvement among Local 500 members
- Educate Winnipeggers about the value of public services and dangers of contracting out and privatization

- The City has given formal notice to the Local that it plans to outsource portions of the Library's Support Services operations.
